On motion offered by Mr. Melvin Keith, seconded by Mr. Jerry Brumfield to accept all three (3) food bids, The Merchants, Arrow-Sysco and Pon Food and buy where cheaper when applicable for a 3-month period. Motion unanimously carried.

On motion offered by Mr. Melvin Keith, seconded by Mr. Jerry Brumfield to reject the bids received on a computer and readvertise at a later date. Motion unanimously carried.

Mr. Keith stated they met with some of the vendors and he thinks it would be appropriate to send them a letter of thanks for them working along with us.

On motion offered by Mr. Melvin Keith, seconded by Mr. Dennis Kates to send a letter to the vendors expressing our appreciation of them working with us during our financial crisis. Motion unanimously carried.

On motion of Mr. Dennis Kates, seconded by Mr. Johnny Crain it was moved to adopt the following Ordinance:

ORDINANCE #22

AN ORDINANCE PROVIDING FOR THE CREATION OF THE WASHINGTON PARISH COMMUNICATIONS DISTRICT. DESCRIBING AND DEFINING THE BOUNDARIES THEREOF AND OTHERWISE PROVIDE WITH RESPECT THERETO.

BE IT ORDAINED by the Police Jury of the Parish of Washington, State of Louisiana, acting as the governing authority of said Parish:

SECTION 1. That, acting under and by virtue of the authority vested in this Police Jury by the Constitution and Laws of this State, including, but not limited to R.S. 33:9101 to 9106, inclusive, (the "Act") there be and there is hereby created a communications district in the Parish of Washington, State of Louisiana, which said communications district shall include and embrace all of that territory within the corporate limits of the Parish of Washington, State of Louisiana, as the same presently exists, and that the boundaries of the communications district hereby created shall be co-extensive with the boundaries of the Parish of Washington, State of Louisiana, as the said boundaries presently exist.

SECTION 2. That the said communications district hereby created shall be known and is hereby designated as "Washington Parish Communications District", and as such shall have all the powers and exercise all the rights, privileges and authority granted by the Constitution and Laws of the State, including the right to incur debt and issue bonds and the right to levy charges, and shall be governed by the Police Jury of the Parish of Washington, State of Louisiana, all as provided in the Act.

SECTION 3. That this Ordinance shall be duly published in the Official Journal of this Police Jury as provided by law.

SECTION 4. That this Ordinance shall be in full force and effect immediately upon its adoption.

This Ordinance having been submitted at a public meeting of said Police Jury, was then submitted to an official vote as a whole, the vote thereon being as follows:

And this Ordinance was declared adopted on this 10th day of May, 1988.

On motion offered by Mr. Glen Sheridan, seconded by Mr. John Dodds to get some trusty's and move the records out of the water in the old jail building. Motion unanimously carried.
